19/125. Correspondence/Communication with Parish Council

- a) Cotswold District Council has begun a 'Call for Sites' for potential housing (including sites for accommodating gypsies and travelling show people) employment, retail, commercial, community and/or other uses. The deadline for submissions is Friday 2 August 2019. The Call for Sites will inform the Council's Strategic Housing and Economic Land Availability Assessment (SHELAA) and other Local Plan evidence documents. The SHELAA provides a broad-brush assessment of the development potential of sites across the District. Whilst this is separate from the Local Plan site allocation process, it will inform future reviews of the Local Plan.
- The Council requests that anyone who has previously submitted sites to the SHELAA should reconfirm their interest and inform the Council of any recent progress in bringing sites forward for development.
- Anyone wishing to submit a site or building for potential development in Cotswold District can do so by completing a site submission form and providing a brief description of the proposal, details of site ownership and a map (preferably 1:1250 scale) with the site area outlined in red. Site submission forms are available to download from the Council's website (<https://www.cotswold.gov.uk/media/1625339/2203-SHELAA-New-Site-Form-DOCX-.docx>) or paper copies are available at the Council's Trinity Road office in Cirencester.

- b) There is an area of land adjacent to the main entrance of St Bartholomews Church that has a public footpath across it & in living memory has been used for parking for church services & funerals etc. This land next to the road has recently been fenced off & labeled as private. I have seen no notice the land was private before & for more than 40 years believe this to be common land. Has this land been stolen?

Clerk has reported this matter to planning enforcement

- c) A parishioner has suggested 'that we should create a signed petition for our community objecting to the ludicrous proposed increase in Valley Trading, and other traffic into Babdown. We think that that this is a justified and very sensible thing to do.'
