### 20/171.Trees at Bagpath Common - update if available

Cllr T Wooldridge reported

- He has contacted CDC Estates Manager, who has advised they are currently awaiting a response from Glos CC, whose team are carrying out their own assessment of the site
- The legal decision is that there is no owner of the Common, nor was there a legal appointment of a local council to take responsibility
- We have asked the district council for clarification. As they have acted it suggests that they
  are taking responsibility for the site. Now that they have involved Glos CC they must feel a
  higher authority has responsibility too
- This is not a satisfactory situation and the parish council were surprised at the length of time taken to give a definitive answer to the legal responsibility
- Glos CC have a considerable number of trees with ash die back so are prioritising works
- Burnt tree (raised at the previous meeting) has still not been removed. Cllr R Gale to follow up

#### 20/172. Hazelcote lane trees

- Cllr G Nicholls advised that the trees need cutting back and raised concerns about the bridge. The trees are overgrowing the carriageway so forcing traffic over
- Cllr T Wooldridge advised he has raised this matter with Glos CC Highways. There is a metre
  of verge wasted due to the overhanging trees, forcing traffic over using the opposite verge
  and damaging boundary fencing
- Cllr T Wooldridge has asked Highways for an update to all outstanding highways matters within the parish but has not received one yet
- Cllr T Wooldridge to contact landowner regarding the cutting back of the trees.
- Cllr G Nicholls has offered to carry out the cutting back of the trees with a hedge cutter if Cllr T Wooldridge can secure permission to do so.
